

Student Membership Terms & Conditions

By joining and using the Flowervision Future Florist Programme and Student Membership Card, you agree to the following Terms & Conditions.

1. Eligibility

The Flowervision Student Membership is available to students who:

- Are aged 16 or over
- Are actively studying floristry
- Are enrolled with a college, recognised flower school or other education provider approved by Flowervision
- Have completed the required application process
- Have provided the requested student information and evidence
- Agree to these Student Membership Terms & Conditions

All applications are individually reviewed and approved by Flowervision. Flowervision reserves the right to approve participating education providers and individual applications.

2. Student Membership Card

The Student Membership Card:

- Is issued to an individual student and is for their use only
- Cannot be shared, transferred or used by another person
- Must only be used by the named cardholder
- May require valid student identification to be presented when requested
- Is intended to support the student's education and legitimate floristry development
- Cannot be used to purchase goods on behalf of another business or individual
- Cannot be used to purchase products for resale

Flowervision reserves the right to withdraw or suspend Student Membership where misuse is suspected or identified.

3. Initial Access

For approximately the first six weeks of membership, students can:

- Shop in store at Flowervision Bristol
- Purchase flowers, plants and sundries
- Access applicable trade pricing
- Attend relevant Flowervision events

During this period, students cannot access the Flowervision webshop, place online orders, receive deliveries or access credit facilities.

4. Webshop Access

Following an induction approximately six weeks into the student's course, delivered by Flowervision or an approved floristry tutor, eligible students may be granted webshop access.

Where webshop access is provided:

- Orders are for collection only
- Payment must be made before collection
- Delivery is not available
- Credit facilities are not available

Flowervision reserves the right to determine whether webshop access is granted, suspended or withdrawn.

5. Payment

All purchases made through a Student Membership must be paid for in accordance with the payment options made available to student members.

No credit terms or credit facilities are available through the Future Florist Programme.

6. Membership Duration

Student Membership is valid for up to **12 months, one academic year, or the duration of the student's course where this is less than 12 months.**

Students wishing to continue their membership beyond this period may be asked to provide evidence that they remain enrolled on an eligible floristry course.

Student Membership will end when the student is no longer eligible for the programme.

7. After Your Studies

Student Membership does not automatically transfer to a full Flowervision trade account.

Once a student has completed their studies, they may apply for a full Flowervision trade account. Applications will be subject to Flowervision's standard eligibility criteria, registration process and Terms of Trade.

8. Programme Benefits and Events

Access to events, educational opportunities, competitions, mentoring, scholarships or other Future Florist Programme initiatives may be subject to availability and additional eligibility requirements.

The availability and nature of these opportunities may change as the programme develops.

9. Misuse of Membership

Flowervision reserves the right to suspend or withdraw Student Membership and associated access if:

- The card or account is shared with another person
- Purchases are made on behalf of another business or individual
- Products are purchased for resale
- False or misleading information has been provided
- The student is no longer eligible for the programme
- The membership is otherwise used outside the intended purpose of the Future Florist Programme

10. Flowervision Terms of Trade

All purchases and use of a Student Membership remain subject to Flowervision's standard Terms of Trade where applicable.

Where there is a conflict between these Student Membership Terms & Conditions and Flowervision's standard Terms of Trade, Flowervision reserves the right to determine the terms applicable to the Student Membership.

11. Changes to the Programme

Flowervision reserves the right to amend, suspend or withdraw the Future Florist Programme, its benefits, access levels or these Terms & Conditions where reasonably required.

Any significant changes affecting existing student members will be communicated where appropriate.
